

OPERATING INSTRUCTION 21/2024

Revocation of Operating Instruction 1/2023 regarding the modification of trading hours for the securities listed on the BME Scaleup segment of BME MTF Equity

BME SCALEUP

The Surveillance Department of BME MTF Equity, based on the experience from other trading segments and taking into account the specific characteristics of the securities listed on the BME Scaleup segment, introduced a second daily auction to determine the price of the securities in the BME Scaleup through Operating Instruction 1/2023 of 5 December regarding the modification of trading hours for the securities listed on the BME Scaleup segment of BME MTF Equity.

However, based on the performance of the securities in this trading segment since the implementation of a second daily auction for price determination, the Surveillance Department of BME MTF Equity considers it more appropriate to implement a single auction in accordance with Sections 3.2.1 and 6.1 of Circular 6/2023 of 26 September regarding the trading rules for shares of companies listed on the BME Scaleup segment of BME MTF Equity.

Therefore, the Surveillance Department of BME MTF Equity has approved this Operating Instruction, which replaces and supersedes Operating Instruction 1/2023 of 5 December regarding the modification of trading hours for the securities listed on the BME Scaleup segment of BME MTF Equity.

In addition, the Appendix lists the securities currently listed on the BME Scaleup trading segment that will be affected by the provision described in this Operating Instruction.

This Operating Instruction will apply from 9 December 2024 inclusive.
