(LRE) from the **BCN MID-50**.

The index adjustment will take place after close of trading on **December 16<sup>th</sup> 2024**, the announced last date of the acceptance period of the Offer.

The above-mentioned measure is subject to the fulfillment of the acceptance period of the launched take-over bid published by CNMV.

These changes will be applied as from **December 17<sup>th</sup> 2024**.
