(TR1)** stock, due to Retex S.p.A. – Società Benefit., launched take-over bid, has decided, pursuant to the powers conferred in section 3.1.3.7 of the Technical Regulations for the Composition and Calculation of the IBEX® Indices and Strategy Indexes on Stocks administrated by Sociedad de Bolsas, to adopt the following special measures:

- With effects as from **December 17th**, to **remove** the stock **Tier 1 Technology, S.A. (TR1)** from the **IBEX GROWTH MARKET® ALL SHARE**. The index adjustment will take place after close of trading on December 16th, the announced last date of the acceptance period of the Offer.
- With effects as from **December 17th**, to **remove** the stock **Tier 1 Technology, S.A. (TR1)** from the **IBEX GROWTH MARKET® 15**, which will be temporarily composed of 14 stocks. The index adjustment will take place after close of trading on December 16th, the announced last date of the acceptance period of the Offer.
- Once the result of the offer has officially been published, the Committee shall take the decisions that consider concerning this respect, which will be communicated well in advance.

The above mentioned measures are subject to the fulfillment of the acceptance period of the launched take-over bid published by the company as [Inside Information](#) in the BME Growth website.
